3. PRODUCER offers to produce the PROJECT for CLIENT in exchange for valuable consideration as specified below.
4. PROJECT will be finished within 7 days of filming.
5. Payment for the PROJECT is due upon delivery of the PROJECT.
6. In the event that the client should experience a change of heart (after the edit), and no longer want the completed version, the client is responsible to pay the balance of the originally agreed upon fee within two weeks.
7. It is agreed that the CLIENT will secure the location as photo ready on the day of the shoot.
8. Ownership of the PROJECT will remain with the CLIENT. PRODUCER has no ownership rights in the final version of the PROJECT.
9. PRODUCER is not liable for any of the content of the PROJECT and any and all damages from the PROJECT are the sole responsibility of the CLIENT.
10. PRODUCER is not responsible for any damages to the filming location.
11. PRODUCER is not held liable for any people in the video changing their mind after the filming of the PROJECT.
